didn't have any tobacco. Kimble said he was told to go to the fishbowl, but left to go to school. Kimble said he got to the control center and Officer Macbeth told him to go to the "hole." Kimble said he asked Ms. Butler why he was in the hole. He said he wanted to know why he was in the hole and he was told racketeering.

Kimble said he asked if inmates could be at the hearing. Kimble said he sent a kyte over to the hearings officer and they wrote received after hearing. Kimble said he sent the kyte on the 10<sup>th</sup>, but he never had a hearing. He said it was a bogus write-up from the beginning because he wouldn't cooperate with them. Kimble said Sergeant Deardon was the one who called and said say that Coleman was doing this. Kimble said he didn't want to be out east, so he told them this is what he was doing. Kimble said when he was in the hole at DSU, Coleman came to see him, and Coleman told him he had talked to CO Marthaler. Coleman said he asked why he had been put in the hole and told Kimble to document everything that was going on. Kimble said the next day, Captain Watson came to the hole on the 4<sup>th</sup>, and was very upset. Kimble said Watson commented on how Kimble had received a visitor and wanted to know why. Kimble said Watson wanted to know where the book was. Kimble said Watson told him he'd never walk the main line at OSP again.

I asked Kimble how he knew where the DVD player had come from. Kimble said at first, Curtis wouldn't tell him. He said first Curtis wanted to sell the DVD player to Kimble for \$400.00 with two DVDs. Kimble said he told Curtis he wouldn't buy it unless he knew where it had come from. Kimble said Curtis told him the DVD player came from the same place the tobacco came from. I asked Kimble how he knew Melanie Johnson was giving tobacco to Curtis. Kimble said Curtis told him Ms. Johnson is where he gets his stuff.

At this point during the interview, Kimble asked if he could get into trouble for this. I explained to Kimble that absolutely he could. He had just admitted to buying tobacco for himself. Kimble then said he didn't want to say anything. However, he continued to talk to me. Kimble continued talking to me about the magazine article with the picture on it. Kimble said he told a staff member about what was going on. Kimble said when he first showed Coleman the picture, Coleman said he wished he had a camera phone. Kimble said he couldn't get copies of the magazine, but instead took it to Butter at work. Kimble said he gave the magazine to Butter and then told Coleman where to get the magazine. I asked Kimble if he knows what happened to the magazine. Kimble said Coleman was supposed to pick it up.

I asked Kimble if he had seen any other staff doing anything else. Kimble said Gino Edwards had lost his job and Captain Mills wanted out there. Kimble said he'd seen how they did him the same way. Kimble said they were trying to do Coleman, but Coleman talked good communications and treated inmates with respect. Kimble said Bjerke called for extra security for meetings in her office that was behind the dude with Inmate Clayton Howard. Kimble said Sergeant Deardon had a "hard on" for Coleman to be gone because Deardon and Gore are tight friends. Kimble said other staff members should know about that. I asked Kimble if anyone else other than Melanie was doing something. Kimble said she was the only one he really knew was doing anything. He said if he knew Coleman was bringing in, "blacks" would have had tobacco, and he wouldn't have had to do business with Curtis.
